- For '**Endowment category**' seats applications (from Online Registered Candidates only) will be accepted till 10.00 AM on 30/07/18.
- '**Endowment Category**' seats will be allotted strictly on the basis of merit.
- The candidates who have been allotted seats in the First and Second round of Counseling shall not be considered for Third and Final round of counseling. This is also applicable for those candidates who have withdrawn their seat after allotment. However this rule shall not be applicable for those candidates seeking seats under Endowment category.
